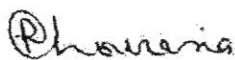

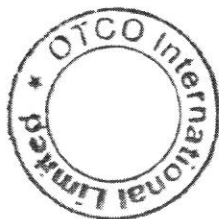

Due to personal reasons and commitments, I find it difficult to devote my time to be the independent director of the Company.

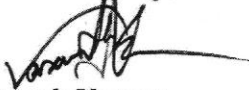
Hence, I hereby tender my resignation to the Board of Directors as an independent director of the company with immediate effect.
